Wall Street Walkway - Ms. Petty gave an overview of the scoping of the Wall and Water Street and proposed new pedestrian walkway. She expressed the need to push for a strong turnout for March 26<sup>th</sup> hearing about the walkway.

Mr. Morse asked about the bus kiosk that has been moved from 70 Depot Square, where it was originally installed by the town's Energy Committee without getting written permission from the owners of the building. Ms. Petty said it was a little too early to consider a new location but that it was in the works.

Norwich/Northfield Communications – Ms. Petty wanted to make sure that the Norwich Task Force was informed regarding the work taking place by the EDD and Norwich to implement an AI solution for better communication.

70 Depot Square – Mr. Davis asked if the Select Board would like a tour of the building, including the four new apartments that are close to completion. There was a strong interest in doing so.

Zoning Bylaw Modifications – Mr. Davis brought up the issue of rural density zoning, where a proposal for converting minimum building size from five acres to two acres has a lot of opposition. He wanted to point out that there are parcels of land currently in rural zoning areas that around surrounded by homes on less than five acres, and zoning should be relaxed for those parcels to ensure Northfield can fulfill its mission of providing more housing.

Ms. Petty pointed out that the modernization of the zoning laws was the priority, but then to address issues like zoning where housing can be constructed.

Mr. Morse noted that the town needs to separate the areas where higher development will impact the roads or traffic from those areas on paved roads that can handle the traffic increase.

## b. Other Matters -

Transportation Oriented Development Program – Ms. Petty asked about any progress on the program. Mr. Davis gave an update that the program was very slow to get moving and hoping to begin soon.
